

# MACON COUNTY LAW ENFORCEMENT TRAINING CENTER

## RENTAL RATES FOR CRIMINAL JUSTICE AGENCIES ONLY

(effective October 1, 2019)

### TRAINING ROOMS/AREAS

- **Tactical Village:** \$450/half day or  
\$750/full day  
*(includes 3-story jail, 2-story apartment complex, convenience store, law office and bank; simunitions are allowed; rules and waiver forms must be signed; class roster provided as in-service training hours; we have simunitions equipment for rent; if you need a classroom in the same building, Classroom D and the NASA Tower Classroom are perfect for briefing, de-briefing, staging, etc.)*
- **Range:** \$15/person for two hours or  
\$25/person for half day (up to 4 hours) or  
\$40/person all day (up to 8 hours)  
*(25 yard, 20 lane indoor climate controlled small arms range; we have weapons for rent, targets and/or backers for sale- ammunition is not for sale; waiver forms must be signed; agency must have a certified instructor or the MCLETC can provide an Instructor for \$32/hour and requalification certificates, if applicable)*
- **Virtra 300 Simulator:** \$160 for two hours or  
\$300 for half day (up to 4 hours) or  
\$560 all day (up to 8 hours)  
*(all rates include a certified Vitra instructor and certificate; waiver forms must be signed)*
- **Driving Simulator:** \$60/hour *(full hours only; i.e. 25 minutes= 1 hour, 75 minutes= 2 hours; all rates include a trained instructor and certificate; waiver forms must be signed)*
- **Physical Skills Room I:** \$250/half day or  
\$425/full day  
*(large mat room in the Tactical Village; waiver forms must be signed)*
- **Physical Skills Room II:** \$175/half day or  
\$300/full day  
*(smaller mat room in the Administration Building; waiver forms must be signed)*

## RENTAL RATES FOR CRIMINAL JUSTICE AGENCIES ONLY

(effective October 1, 2019)

- **Training Room 1:** \$100/day (*mock courtroom; waiver forms must be signed*)
- **Training Room 2:** \$75 day (*mock jail intake/processing area; waiver forms must be signed*)
- **Training Room 3:** \$75 day (*mock one bedroom apartment; waiver forms must be signed*)
- **Training Room 4:** \$100 day  
(*multi-purpose room; can be set up as classroom with AV equipment, holds up to 36- additional AV fee is \$40; waiver forms must be signed*)

## CLASSROOMS

- **Boardroom:** \$175/half day or  
\$300/full day  
(*includes kitchenette, large conference table, 20 leather conference chairs, 4 furniture chairs, hands-free conference phone, AV equipment and white board*)
- **Classroom A:** \$225/day  
(*holds up to 60; includes room set up and AV equipment; inside Administration Building*)
- **Classroom B:** \$140/day  
(*holds up to 40; includes room set up and AV equipment; inside Administration Building*)
- **Classroom A and B combined:** \$325/day  
(*holds up to 110 with desks, 150-200 with chairs only; includes room set up and AV equipment; inside Administration Building*)
- **Classroom C:** \$225/day  
(*holds up to 60; includes room set up and AV equipment; inside Bolek Training Facility*)

## RENTAL RATES FOR CRIMINAL JUSTICE AGENCIES ONLY

(effective October 1, 2019)

- **Classroom D:** \$50/day, if rented with Tactical Village  
\$140/day without the Tactical Village  
(holds up to 36, *includes room set up and AV equipment*); inside Tactical Village)
- **NASA Tower Classroom:** \$25/day, if rented with Tactical Village  
\$100/day without the Tactical Village  
(holds up to 40, *includes room set up*); inside Tactical Village)
- **Paper Copies:** rates furnished upon request (*black and white or color*)

### FOOD SERVICE

(*ala carte or meal plans*)

- **Cafeteria:** no fee, if meals are purchased (*additional AV fee is \$40*)  
\$150/day for meetings (*includes set up and AV equipment*)
- **Continental breakfast:** \$6/person  
(*example- small pastries, muffins, donuts, fresh fruit, coffee and orange juice*)
- **Full hot breakfast:** \$10/person  
(*example- scrambled eggs, hash browns or pancakes/waffles, bacon or sausage, yogurt and cereal with fixings, coffee and orange juice*)
- **Lunch:** \$10/person (*examples- taco bar with all the fixings or hamburgers and fries or barbecue sandwich, cole slaw and chips or tots, all with drinks*)
- **Mid-day snacks:** \$4/person (*example- cookies or brownies with lemonade and ice tea; we also have chex mix, chips, etc.*)
- **Dinner:** \$11/person (*examples- meatloaf or fried chicken, mashed potatoes, vegetable, salad and dessert with lemonade and iced tea, or lasagna, garlic bread, salad and dessert with drinks*)
- **Meal Plans with Housing:** \$1 off each meal with an overnight stay or  
\$5 off each day if all three meals purchased (with lodging)

**OVERNIGHT HOUSING**

- Residential Hall rooms:
  - Option 1: \$45/night single occupancy (includes twin bed, wifi and tv in room) **or**
  - Option 2: \$55/night single occupancy (includes double bed, wifi and tv in room) **or**
  - Option 3: \$65/night double occupancy (includes twin beds, wifi, and tv in room) **or**
  - Option 4: \$35/night single occupancy (includes twin bed, wifi and tv in lounge) **or**
  - Option 5: \$60/night double occupancy (includes twin beds, wifi, and tv in lounge)

Billiard table and table tennis (ping pong) are available in lounges; vending and ice machines on the second floor
